BOOKING TERMS AND CONDITIONS - GENERAL CONDITIONS AND CANCELLATION

Below are our booking and cancellation conditions, valid for all bookings made with CORTINA360 SRL and GUIDE ALPINE CORTINA360 - Scuola d'Alpinismo through our channels.

Therefore, they are considered read and accepted at the time the request is sent.

The reservation is to be considered confirmed only after our written communication and after the payment of the required deposit. The request and confirmation emails have the value of contract between the parties according to the Italian legislation and are binding for those who make the reservation and for all other subjects mentioned in the same, including minors.

BOOKING CONDITIONS

- For every outing we make, the reservation must be made no later than the evening before the beginning of the activity, unless otherwise indicated.
- The costs indicated are per person for group outings and per day for a private guide. Prices vary according to season, number of people and the type of activity required.
- For group outings, in the case where the minimum number of participants is not reached, a surcharge will be applied, or the group will be cancelled upon notice.
- Times and itineraries may vary depending on weather conditions.
- CORTINA360 SRL and GUIDE ALPINE CORTINA360 Scuola d'Alpinismo reserve the right to modify the itinerary in the event of any accessibility or weather problems as well as the insufficient health and/or fitness of the customer.
- · For special packages and personalized offers, different and specific booking conditions will be communicated.

DEPOSIT

Reservations are confirmed only after the payment of a deposit equal to 30% of the total amount, according to the methods indicated in our confirmation email, or according to specific agreements between the parties.

For special packages and customized offers, different and specific deposit amounts will be communicated.

BALANCE

The balance of the amount due must be paid by the morning before departure, unless otherwise communicated for specific and multi-day activities. For special packages and personalized offers, different and specific conditions for the payment of the balance will be communicated.

CANCELLATION/CANCELLATION

The reservation is made for a specific date.

- If the cancellation of the reservation takes place within 15 days before the date of the service the total deposit paid (which is equal to 30% of the amount of the service) will be returned minus 10% of the total amount for secretarial costs.
- If the cancellation of the reservation takes place after 15 days from the date of the service, all of the deposit paid or an amount equal to 30% of the total service will be retained.
- Different and specific cancellation policies may be communicated for packages and types of particular services.
